FEES FOR ADOPTION

Dogs or Puppies (Fee Per Animal)	\$50.00
Cats or Kittens (Fee Per Animal)	\$30.00
Animals Other Than Dogs, Puppies, Cats, or Kittens (Fee Per Animal)	\$10.00

FEES FOR RELEASES OF IMPOUNDED DOGS

Release of a Unlicensed Dog Impounded for Running at Large as Defined in Chapter 117-8	\$50.00
Release of a Dog Impounded Off the Premises of the Owner or Person Keeping or Harboring the Dog And Believed To Be a Stray Dog	\$50.00
Release of a Dog Off the Premises of the Owner or the Person Keeping or Harboring the Dog Without A Current Registration Tag on Its Collar	\$50.00
Release of Any Female Dog Impounded Which Was In Season off the Premises of the Owner or The Person Keeping or Harboring The Dog	\$50.00
