**ORDINANCE NO. 1798-09**

**ORDINANCE AMENDING CHAPTER 295 OF THE CODE  
OF THE CITY OF PASSAIC "VEHICLES AND TRAFFIC"**

**WHEREAS**, the Parking Authority of the City of Passaic adopted a resolution on April 23, 2009 rescinding their previous recommendation concerning changes in the hours of operation for metered parking; and

**NOW THEREFORE, BE IT ORDAINED** by the Council of the City of Passaic that the following revisions shall be made to the hours for parking meters:

**SECTION ONE**

That Section 295-7 "Metered Time Limit Parking" shall be amended to delete the following:

B. No person shall park a vehicle for longer than the two-hour metered time limit at any time between the hours of 8:00 a.m. and 8:00 p.m. Monday through Saturday (except holidays), in any municipal parking lot equipped with parking meters. This restriction shall not apply to municipal parking lots designated as permit parking facilities.

The following shall be substituted therefore:

B. No person shall park a vehicle for longer than the two-hour metered time limit at any time between the hours of 8:00 a.m. and 6:00 p.m. Monday through Saturday (except holidays), in any municipal parking lot equipped with parking meters. This restriction shall not apply to municipal parking lots designated as permit parking facilities.

**SECTION TWO**

Section 295-23 "Schedule IV: Metered Time Limit Parking":

All areas designated in Section 295-23 for metered parking shall revise the time limit; hours/days to change from two hours: 8:00 a.m. to 8:00 p.m. to two hours: 8:00 a.m. to 6:00 p.m.

**SECTION THREE**

If any section or provision of this ordinance shall be held invalid in any court, the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid and shall be inseparable from the remainder or any portion thereof.

**SECTION FOUR**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION FIVE**

This ordinance shall take effect upon final passage and publication as provided by law.


