**RESOLUTION OF THE CITY OF PASSAIC  
PARKING AUTHORITY BOARD OF COMMISSIONERS  
APPROVING CONTRACT BETWEEN MPS, INC.  
AND THE CITY OF PASSAIC FOR PARKING METER SYSTEM.**

WHEREAS, the Parking Authority of the City of Passaic (the "Authority"), a public body corporate and politic of the State of New Jersey, was created pursuant to the Parking Authorities Law, N.J.S.A. 40:11A-1 et. seq. (the "Parking Authority Law") for the purposes of managing, operating, maintaining and improving certain parking facilities and meters located in the City of Passaic; and,

WHEREAS, the City of Passaic has adopted a resolution awarding a Contract With Municipal Parking Services, Inc., for the Sentry Total System Solution Parking System<sup>®</sup>, which resolution is consistent with the purposes of the Authority as set forth above; and,

WHEREAS, Municipal Parking Services, Inc., has previously presented its Sentry Total System Parking System<sup>®</sup> to the Passaic Parking Authority in a public meeting; and,

WHEREAS, the Passaic Parking Authority has determined that the Sentry Total System Parking System<sup>®</sup> is consistent with the Passaic Parking Authority's charge to improve parking in the City of Passaic through contemporary technical, logistical and planning concepts and technologies:

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Parking Authority of the City of Passaic, County of Passaic, State of New that the award of a contract to Municipal Parking Services, Inc., for the Sentry Total System Solution Parking System<sup>®</sup> is approved; and, it is

FURTHER RESOLVED by the Board of Commissioners of the Parking Authority of the City of Passaic, County of Passaic, State of New Jersey, that the Executive Director and Board Chairperson are authorized to execute any documents required by the City of Passaic to implement the award of said contract or installation of the Sentry Total System Solution Parking System<sup>®</sup>.
