**RESOLUTION RECOMMENDING THAT THE CITY OF PASSAIC  
 AUTHORIZE THE DESIGNATION OF ADDITIONAL ANGLED PARKING  
 AT THE WILLIAM STREET PARKING LOT**

WHEREAS, the Parking Authority of the City of Passaic (the "Authority"), a public body corporate and politic of the State of New Jersey, was created pursuant to the Parking Authorities Law, N.J.S.A. 40:11A-1 et. seq. (the "Parking Authority Law") for the purposes of managing, operating, maintaining and improving certain parking facilities and meters located in the City; and,

WHEREAS, the City of Passaic must designate by Ordinance duly adopted the designation of any parking facility, space or location within the City of Passaic, and the rate or rates to be charged therefor; and,

WHEREAS, the City of Passaic Parking Authority has caused a preliminary study of additional angled parking at the William Street Parking Facility, a copy of which is annexed hereto as if more fully set forth at length herein, whereby an additional thirteen (13) paying parking spaces could be provided therein; and,

WHEREAS, the City of Passaic Parking Authority has determined that the provision of an additional thirteen (13) paying parking spaces would assist in fulfilling the purposes of managing, operating, maintaining and improving certain parking facilities and meters located in the City, and further assist the merchants and residents of the City of Passaic in providing additional parking at the location:

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Parking Authority of the City of Passaic, County of Passaic, State of New Jersey that the City of Passaic Parking Authority requests that the City Council of the City of Passaic authorize by Ordinance the addition of thirteen (13) paying parking spaces to be constructed at the William Street Parking Facility in the City of Passaic.


